ARTICLE I -- NAME

The name of the limited liability company shall be 2215 GULF GATE, LLC ("company").

ARTICLE II -- ADDRESS

A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all the members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.
