

ARTICLES OF ORGANIZATION OF BOOTHCO SAVANNAHS, LLC

These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 508)

Article 1 - Name
