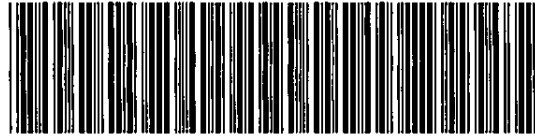


Please let this letter serve formal and immediate notice of resignation of Managing Member and as temporary President of Americorp Enterprise, LLC, as of today's date.


