#### ARTICLES OF ORGANIZATION OF ALL SEASONS HOME CARE, LLC

#### **ARTICLE I**

#### **NAME**

The name of this limited liability company (the "Company") shall be **All Seasons Home**Care, LLC and its mailing address and principal place of business is 8951 N.W. 34<sup>th</sup> Street, Cooper

City, Florida 33024.

#### **ARTICLE II**

#### **COMMENCEMENT OF COMPANY EXISTENCE**

The Company shall commence existence on the date these Articles of Organization are filed with the Corporations Division of the Florida Department of State and shall have perpetual existence unless sooner dissolved according to its Operating Agreement or law.

#### ARTICLE III

#### GENERAL PURPOSE; GENERAL POWERS

The general purpose of the Company shall be the owning, management, and operation of a home health care business and any other lawful business necessary or helpful in carrying out such purposes. The Company shall have all of the powers enumerated in the Florida Limited Liability Company Act, as the same now exists and as hereafter amended, and all such other powers as are permitted by applicable law.

#### **ARTICLE IV**

#### INITIAL REGISTERED OFFICE AND AGENT

The name of the initial registered agent of the Company is Patricia Heuberger and the registered office address is 8951 N.W. 34<sup>th</sup> Street, Cooper City, Florida 33024. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

#### ARTICLE V

#### **MANAGEMENT**

The Company shall be managed by a Manager or Managers as set forth in the Operating Agreement adopted by the Company. Except as otherwise stated in the Company Operating Agreement, the Manager or Managers has sole authority to manage the Company and is authorized to make any contracts, enter into any transactions, and make and obtain any commitments on behalf of the Company to conduct or further the Company's business. This provision does not alter or waive any duty that the Manager or Managers may have to the Company concerning the Manager's or Managers' exercise of management authority.

#### ARTICLE VI

#### **OPERATING AGREEMENT**

The power to adopt, alter, amend or repeal the Operating Agreement of the Company shall be vested in the Members and shall require the approval of the Manager or Managers and of Members owning more than fifty percent (50%) of the Membership Units.

#### **ARTICLE VII**

#### **ADMISSION OF NEW MEMBERS**

Additional Members may not be admitted except upon compliance with tems and conditions set forth in the Operating Agreement.

#### **ARTICLE VIII**

### <u>DEATH, RETIREMENT, RESIGNATION, BANKRUPTCY, EXPULSION, DISSOLUTION OF MEMBER</u>

In the event of the death, retirement, resignation, bankruptcy, expulsion or dissolution of a Member or the occurrence of any other event which terminates the continued membership of a Member in the Company, the Manager or Managers may continue the business of the Company without a vote of the Members so long as there is at least one (1) remaining Member of the Company.

#### **ARTICLE IX**

#### <u>AMENDMENT</u>

The right to amend or repeal any provisions contained in these Articles of Organization, or any amendment hereto, shall require approval of the Manager or Managers and of Members owning more than fifty percent (50%) of the Membership Units.

#### ARTICLE X

#### **HEADINGS AND CAPTIONS**

The headings or captions of these various Articles of Organization are inserted for convenience and none of them shall have any force or effect, and the interpretation of the various articles shall not be influenced by any of said headings or captions.

ARTICLE XI

RELATIONSHIP OF ARTICLES OF ORGANIZATION
TO OPERATING AGREEMENT

If a provision of these Articles of Organization differs from a provision of Company's Operating Agreement, then, to the extent allowed by law, the Operating Agreement will govern.
