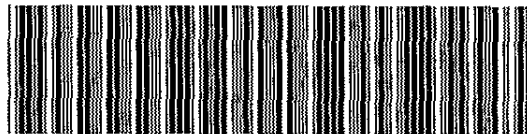

ARTICLES OF ORGANIZATION OF CUSTOM CREATIONS, LIMITED LIABILITY COMPANY

The undersigned, desiring to form a Limited Liability Company, in accordance with the laws of the State of Florida, does hereby adopt the following as the Articles of Organization of such company whose existence shall begin as of August 1, 2006.

ARTICLE I - NAME:

The name of the Limited Liability Company is Custom Creations, L.L.C. (hereinafter referred to as "the company").

ARTICLE II - ADDRESS:

ARTICLE IV - MANAGEMENT:

The company is to be managed by one or more members who shall also hold the offices and have the responsibilities accorded to them by the operating regulations. Except as may be otherwise provided in the operating regulations, no debt shall be contracted nor contractual liability incurred by or on behalf of the Company, except by one or more of its managers. The power to adopt, alter, amend, or repeal the regulations of the Company shall be vested in the manager(s). The name and address of the managing member is:

ARTICLE V - ADMISSION OF ADDITIONAL MEMBERS:

Additional members may be admitted at such time and on such terms and conditions as all members may unanimously consent, in writing, and as provided in the operating regulations.

ARTICLE VI - MEMBERS RIGHTS TO CONTINUE BUSINESS:

The remaining members of the company, if any, shall have the right to continue the business upon death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or occurrence of any other event which terminates the continued membership of a member, at their election and option upon unanimous written agreement, and as provided in the operating regulations.

ARTICLE VII -INDEMNIFICATION OF MEMBERS :

Neither the members nor the managers of the Company shall be liable under a judgment, decree, or order of a court, or in any other manner, for a debt, obligation, or liability of the Company except as provided by Florida Statute.

The company shall indemnify any person made a party to any proceeding by reason of the fact that he is or was a member, manager, officer, employee or agent of the Company, against liability incurred in the proceeding if :

- (a.) He conducted himself in good faith ;
- (b.) He reasonably believed that his conduct was in, or at least not opposed to, the Company's best interests; and
- (c.) In the case of any criminal proceeding, he had no reasonable cause to believe his conduct was unlawful.

Indemnification shall also be provided for an individual's conduct with respect to an employee benefit plan if the individual reasonably believed his conduct to be in the best interests of the participants in and beneficiaries of the plan.

(All personal pronouns in this document, whether used in the masculine or feminine gender, shall include the other gender; the singular shall include the plural and the plural shall include the singular)

ARTICLE VIII - SHARING OF PROFITS AND LOSSES

The profits and losses of the Company shall be allocated among the members in the manner provided in the operating regulations.

The undersigned member of Custom Creations, L.L.C. certifies:


1. The above named limited liability company has at least one member;
