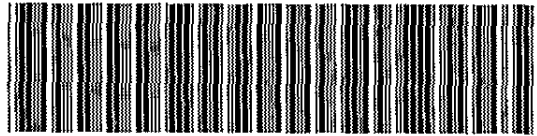

ARTICLES OF ORGANIZATION
OF

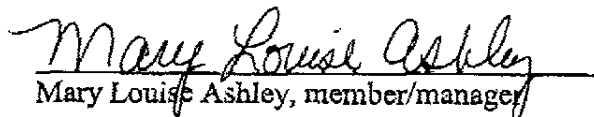

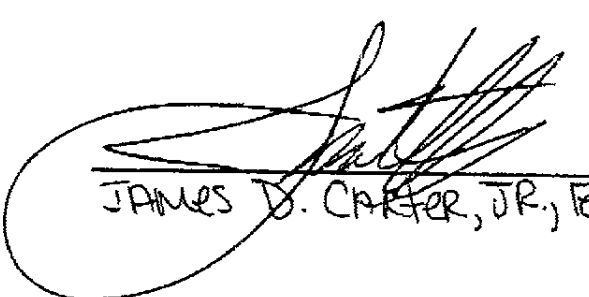
