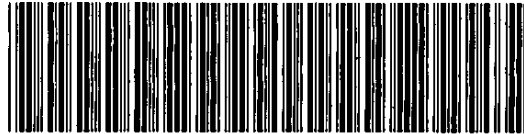

ARTICLE I

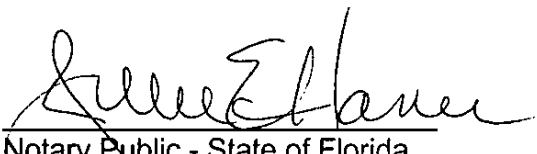

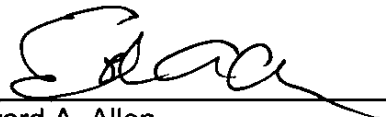
