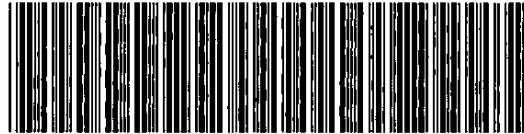

1. Name. The name of the limited liability company is Oak Financial, LLC.


8. Additional Members. The names and addresses of additional members(s) are as follows:
