ARTICLES OF ORGANIZATION OF

5500 Jammes Road, LLC (A Florida Limited Liability Company) (Single Member)

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.
