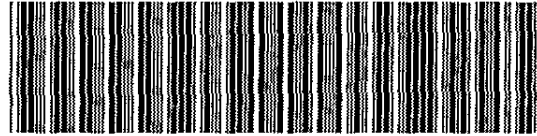


Dear Sir/Madam:

The undersigned, Randal C. Fairbanks, Esq., as authorized representative of the members and managers of SAI, LLC (the "Company"), on behalf and in the name of the Company, pursuant to the Florida Limited Liability Company Act, hereby adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is SAI, LLC.
2. The Articles of Organization of the Company were filed on August 8, 2006.
