ARTICLES OF AMENDMENT AND RESTATEMENT TO THE ARTICLES OF ORGANIZATION OF DORSCH SALTAIR PROPERTIES, LLC

Dorsch Saltair Properties, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "LLC"), pursuant to Section 605.0202, Florida States, hereby files these Articles of Restatement and Amendment to the LLC's Articles of Organization (the "Articles of Restatement and Amendment") and certifies as follows:

- 1. The Articles of Organization for the LLC were filed on August 9, 2006 with the Florida Secretary of State.
- The LLC was assigned document number L06000078479.
- 3. The amendments include a change of the name of the LLC to Atlantic Saltair Properties, LLC, a conversion of the LLC from a Member-Managed LLC to an achange in the Registered Agent.
- 4. The Articles of Organization of the LLC as heretofore amended or supplemented are hereby restated and further amended to read in their entirety as follows:

ARTICLES OF AMENDMENT AND RESTATEMENT TO THE ARTICLES OF ORGANIZATION FOR ATLANTIC SALTAIR PROPERTIES, LLC

ARTICLE I

The name of this Limited Liability Company shall be: Atlantic Saltair Properties, LLC (hereinafter referred to as the "Company").

ARTICLE II
