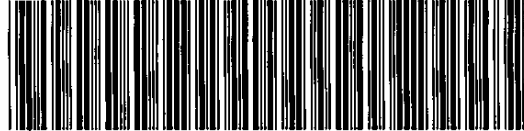

**ARTICLES OF ORGANIZATION  
OF  
AMERICAN INTEGRITY GROUP - FLORIDA, L.L.C.**

I, the undersigned natural person of the age of eighteen years or more, acting as the organizer of a limited liability company under Title XXXVI, Chapter 608, Florida Statutes, commonly known as the Florida Limited Liability Company Act, do hereby adopt the following Articles of Organization for such company.

**ARTICLE ONE**

**NAME AND ADDRESS**

### REGISTERED AGENT AND OFFICE

The Managers may from time to time designate one or more officers for the Company, but shall not be obligated to do so. Likewise, the Managers may from time to time remove any such designated officer or officers.


**ARTICLE NINE****LIMITATION OF LIABILITY**

No Manager of this limited liability company shall be liable to the limited liability company, or to its Members, for monetary damages for an act or omission in the Manager's capacity as a Manager, except for liability of a Manager for (a) a breach of a Manager's duty of loyalty to the Company and its Members, (b) an act or omission not in good faith that constitutes a breach of duty of the Managers to the limited liability company, or an act or omission which involves intentional misconduct or a knowing violation of the law, (c) a transaction from which a Manager received an improper benefit, whether or not the benefit resulted from an action taken within the scope of the Manager's position, or (d) an act or omission for which the liability of a Manager is expressly provided for by an applicable statute.

If the Florida Limited Liability Company Act, or any other applicable law is amended or enacted to authorize a further elimination or limiting of the liability of Managers, then the liability of a Manager of this limited liability company shall be eliminated or limited to the fullest extent permitted by the Florida Limited Liability Company Act or any other applicable law, as so amended.

Any repeal or modification of the foregoing provision contained in this Article by the Members of the limited liability company shall not adversely affect any right or protection of a Manager existing at the time of such repeal or modification.


