





ARTICLE I

ARTICLE VI

PURPOSE: The purposes for which the LETITIA INVESTMENTS, L.L.C. is formed are:

- (A) To invest in real property and otherwise deal in the real estate industry within and outside the State of Florida, subject to such laws and regulations governing the licensing and other requirements pertinent thereto, on its own account and for the accounts of others; and


