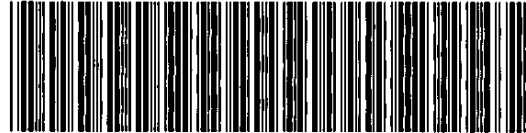

The period of duration for Miller-Hagan Holdings, LLC shall be perpetual.

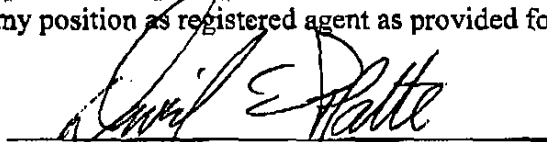
**ARTICLE IV - Registered Agent:**

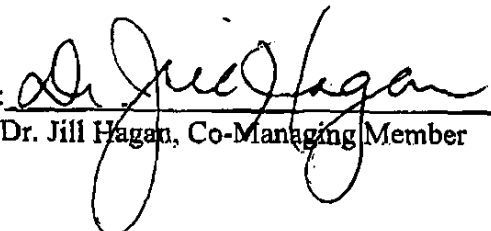
