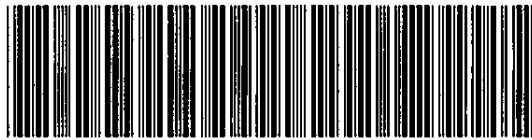



1. That Article I, is hereby deleted in its entirety and the following inserted in lieu thereof:




