

ARTICLES OF ORGANIZATION OF Burning Meadows, LLC

The undersigned, desiring to organize and establish a limited liability company pursuant to the laws of the State of Florida, executes these Articles of Organization this ______ day of _______, 20_06___.

ARTICLE I NAME

The name of the limited liability company is Burning Meadows, LLC.

ARTICLE II DURATION

The period of duration for this limited liability company is seventy (70) years from the date of filing the Articles of Organization with the appropriate state filing office, unless extended and/or sooner dissolved by the members or as provided by state law.
