**Article I
Name**

The name of the limited liability company ("Company") is Lulu's All American Diner, LLC.

**Article II
Address**


**Article VII
Admission of New Members**

Members of the Company have the right to admit new members. **Article VIII

The business may be continued only on the unanimous consent of the remaining members.
