**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
DECKS AND DOCKS LUMBER AND RAIL SERVICE, LLC**

Pursuant to Section 608.411 of the Florida Limited Liability Company Act, DECKS AND DOCKS LUMBER AND RAIL SERVICE, LLC adopts these Articles of Amendment:

1. Name. The name of the Company is **Decks and Docks Lumber and Rail Service, LLC** (the "Company").

2. Articles of Organization. The date of filing of the Articles of Organization of the Company was August 11, 2006 (Document Number L06000079723).

3. Amendment. The Articles of Organization of the Company are hereby amended as follows:

Article I is deleted and a new Article I is inserted in lieu thereof, to read as follows:

**ARTICLE I
NAME**

The name of the Company shall be: **DECKS AND DOCKS MARINE SUPPLY, LLC.**
