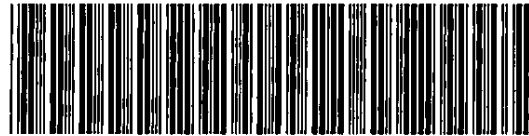

**ARTICLES OF ORGANIZATION OF
UNITED INVESTMENT PROPERTY, LLC**

Article I

The name of the limited liability company ("Company") is UNITED INVESTMENT PROPERTY, LLC.

Article II

The mailing address of the Company is 862 Westchester Dr., DeLand, Florida 32724 and street address of the Company's principal office is also 862 Westchester Dr., DeLand, Florida 32724. The members shall have the power and authority to establish branch offices, or to change the location of the principal office, to such other places as the members may designate.

Article III

The period of duration for the Company is perpetual.
