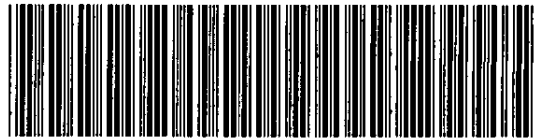

As of October 31, 2008, we are requesting to dissolve LA Aviation Services, LLC, we are no longer operating and would like to close the business with the state.


