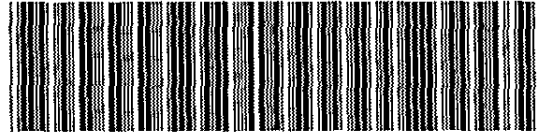

The Company is to be managed by the members and the name and address of the initial managers are:


