**AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF  
GREEN-EAST BAY LENDER, LLC**

1. The name of this limited liability company is Green-East Bay Lender, LLC, a Florida limited liability company, whose principal office and business mailing address is 7301 SW 57<sup>th</sup> Court, Suite 565, South Miami, Florida 33143.

2. The Articles of Organization of Green-East Bay Lender, LLC, originally filed August 14, 2006, under Document No. L06000080284, are hereby deleted in their entirety and amended and restated to read as follows:

**ARTICLE I. NAME**

The name of the limited liability company is Greenwald Air, LLC ( the "Company").

**ARTICLE II. MAILING AND STREET ADDRESS**

The mailing address and street address of the principal office of the Company shall be 7301 SW 57<sup>th</sup> Court, Suite 565, South Miami, Florida 33143.
