The name of the limited liability company is RFD (US) LLC.

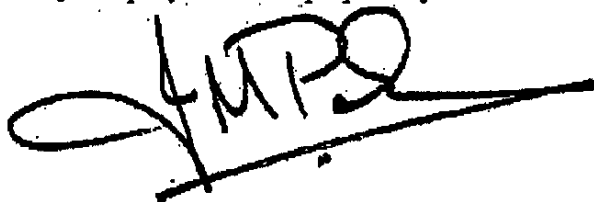
