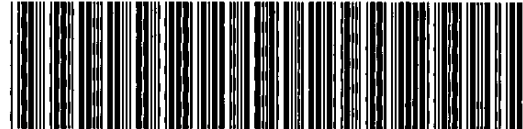

**ARTICLES OF ORGANIZATION
OF
2888 MAHAN DRIVE 1, LLC**

These Articles of Organization of 64 Ridgetop Drive, LLC are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

Article 1 – Name

The name of this limited liability company is 2888 Mahan Drive 1, LLC ("Company").

Article 2 – Purpose

The purpose for which the Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.

The Members shall have the power to adopt, alter, amend, or repeal the Operating Agreement of the Company containing provisions for the regulation and management of the affairs of the Company.


