ARTICLES OF ORGANIZATION OF KEL-J VENTURES, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I

Name. The name of the limited liability company shall be KEL-J VENTURES, LLC ("Company").

ARTICLE II

ARTICLE III
