ARTICLES OF AMENDMENT TO
ARTICLES OF ORGANIZATION OF
LIBERTY VALUE PLACE MANAGEMENT, LLC
(A Florida Limited Liability Company)

Pursuant to Section 608.411, Florida Statutes, LIBERTY VALUE PLACE MANAGEMENT, LLC, a Florida limited liability company (the "Company"), hereby adopts the following Articles of Amendment:

- FIRST: The Articles of Organization were filed on August 16, 2006, and assigned document number LD6000081188.
- SECOND: Article I of said Articles of Organization is amended in its entirety to change the name of the Company from "LIBERTY VALUE PLACE MANAGEMENT, LLC" to "LIBERTY VP MANAGEMENT, LLC", by deleting the provision of said Article I as the same now exists and by substituting in lieu thereof, the following:

"ARTICLE I - NAME"
