ARTICLES OF ORGANIZATION MIDNIGHT FISHERMAN, L.L.C.

The undersigned, for the purposes of forming a limited liability company under the Florida Limited Liability Company Act, hereby make, acknowledge and file the following Articles of 5 Organization:

ARTICLE I - NAME
