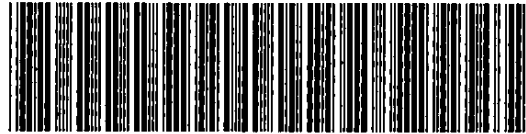

**ARTICLE IV - INITIAL REGISTERED OFFICE AND REGISTERED AGENT**






