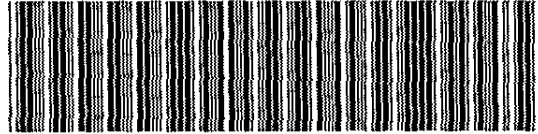

ARTICLES OF ORGANIZATION

FOR

PALSCHER LAKELAND, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be PALSCHER LAKELAND, LLC ("Company").

ARTICLE II -- ADDRESS

The mailing address and street address of the principal office of the Company shall be 238 East Davis Boulevard, Suite 200, Tampa, Florida 33606.

ARTICLE III -- DURATION
