

ARTICLES OF OTO OF RESIDENT INVESTMENT, LLC

The undersigned, for the purpose of forming a limited liability company of under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby triake, and file the following Articles of Organization.

The name of the limited liability company shall be:

RESIDENT INVESTMENT, LLC ("Company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

The company shall commence its existence on the date these articles of organization are filed by the Florida Department of State or on another effective date if specified. ARTICLE V - ADMISSION OF NEW MEMBERS

ARTICLE VI - MEMBER'S RIGHT TO CONTINUE BUSINESS

The company shall be dissolved on the death, bankruptcy, or dissolution of a member or manager, or on the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority vote of the remaining members.

ARTICE VII - MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization.
