3. The following amendment to the Articles of Organization was adopted by the Organizing Member and current Manager on November 8, 2006:



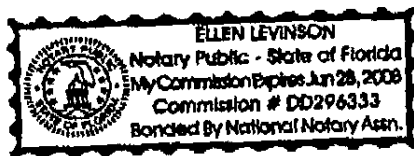
