The undersigned certifies that I have organized for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies.

**ARTICLE I**  
(Name and Principal Place of Business)

The name of the limited liability company is BRU-KAN, LLC, and the mailing address and street address of its principal office is 612 East Amelia Street, Orlando, FL 32803-5320.

**ARTICLE II**  
(Duration)

**ARTICLE V**  
(Right to Continue Business)




