ARTICLE V - AUTHORIZED MEMBERSHIP INTERESTS

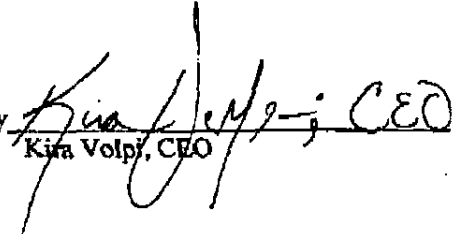
The Company is authorized to issue 1,000 units of membership interests. No additional membership interests shall be issued, without the unanimous consent of the members.
