# AMENDED AND RESTATED ARTICLES OF ORGANIZATION of RADIUS RAIL LOGISTICS, LLC

#### ARTICLE I

### NAME AND ADDRESS

The name of the limited liability company shall be Radius Rail Logistics, LLC (the "Company"). The mailing and street address of the principal address of the Company shall be 550 Balmoral Circle North, Suite 307, Jacksonville, Florida 32218.

### ARTICLE II

#### **PURPOSES AND POWERS**

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

#### ARTICLE III
