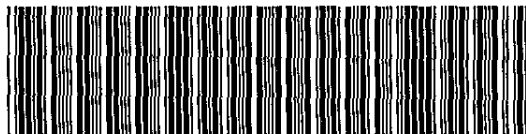

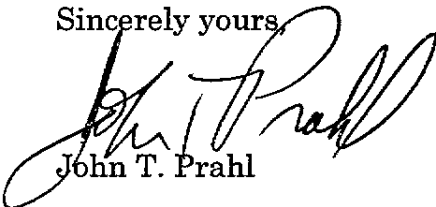

ARTICLE IX **MEMBERS' RIGHT TO CONTINUE BUSINESS**

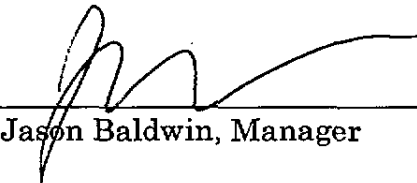
