<u>PLAN OF MERGER</u>

THIS PLAN OF MERGER (this "Agreement") is made and entered into as of the 16th day of April, 2011, by and between THE GRAND MARLIN, LLC, a Florida limited liability company (the "Merged Entity"), and PROM QUEEN-II, LLC, a Florida limited liability company ("FQ-II" and collectively with the Merged Entity, the "Constituent Entities"), with the Merged Entity merging with and into PQ-II, such that the separate existence of the Merged Entity shall cease and PQ-II shall continue as the surviving entity (the "Merger").

RECITALS:

WHEREAS, PQ-II is the sole member of the Merged Entity; and
