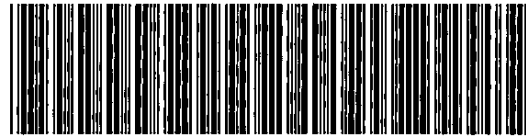



The mailing address and street address of the principal office of the limited liability company is 945 N.E. 82nd Street, Miami Shores, Florida 33138.


**ARTICLE III


