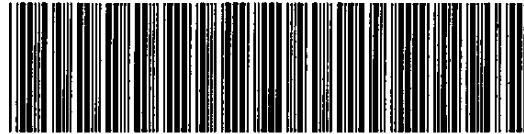



ARTICLES OF ORGANIZATION OF

HLD, L.L.C.

ARTICLE I

Name

The name of the Limited Liability Company is HLD, L.L.C.

ARTICLE II

Address

Continuation of Business



