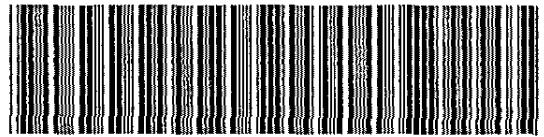


The management and control of the Company shall be vested in its members unless and until a manager is elected by a majority of members.
