

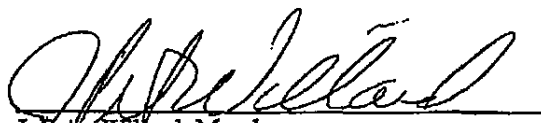
**ARTICLE V - Purpose of Limited Liability Company:**
