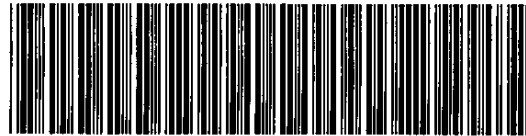

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be: LEE & ASSOCIATES 002, L.L.C.

**ARTICLE II  
PURPOSE**

company.


## **ARTICLE VI PROPERTY**
