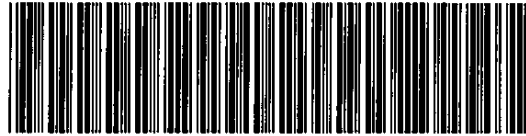

**ARTICLE I**  
**NAME**

The name of this Limited Liability Company shall be: LEE & ASSOCIATES 010, L.L.C.

**ARTICLE II**

company.


#### **ARTICLE VI PROPERTY**


