BANKS, a natural person competent to contract and a member of FORT WALTON BEACH PROFESSIONAL CENTER, LLC, hereby presents these Articles of Organization as the Articles of Organization of FORT WALTON BEACH PROFESSIONAL CENTER, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is:

This limited liability company is referred to in these articles of organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
