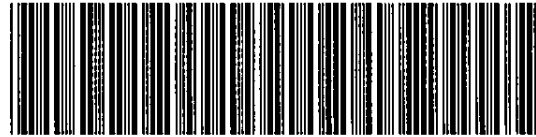

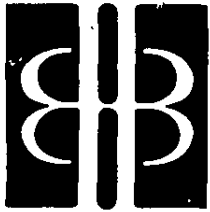

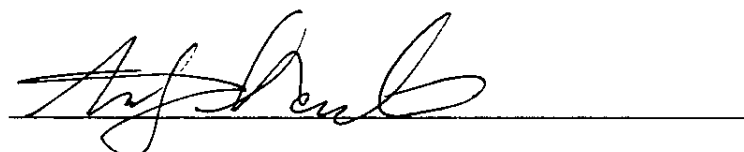
## ARTICLES OF DISSOLUTION FOR MBTLH, LLC
