Effective at 12:01 a.m. on the date of this filing, Midway Town Center, LLC, a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby submit the following Articles of Organization pursuant to Sections 608.407 and 608.4081. Fla. Stat.

ARTICLE 1 NAME

The name of the limited liability company shall be Midway Town Center, LLC.

ARTICLE 2 DURATION
