# ARTICLES OF ORGANIZATION OF ROOI: DOCTORS X-PERTS, LLC

the interest of the member shall have no right to participate in the management of the business

and affairs of this limited liability company or to become a member. Such transferee shall be

entitled to receive only the share of profits or other compensation by way of income and the

return of contributions to which that member otherwise would be entitled.
