TIPPETT, II, a natural person competent to contract and a member of TIPPETT BOATS, LLC, hereby presents these Articles of Organization as the Articles of Organization of TIPPETT BOATS, LLC, a limited liability company formed under the provisions of Chapter 608, Florida Statutes.

**ARTICLE I - NAME**

The name of the limited liability company is:

This limited liability company is referred to in these articles of organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

Unless otherwise provided in the Operating Agreement for the Company, these Articles of Organization or any amendment thereto may be amended in accordance with the Florida Limited Liability Company Act.
