**THIRD AMENDED AND RESTATED  
ARTICLES OF ORGANIZATION  
OF

The undersigned, pursuant to the provisions of Section 608.411 of the Florida Statutes, desires to amend and restate the Second Amended and Restated Articles of Organization of Indigo Apartments at Winter Park, LLC, filed with the Florida Department of State on September 27, 2007, and hereby adopts the Third Amended and Restated Articles of Organization set forth below:

The following Third Amended and Restated Articles of Organization (the "Articles") were adopted and approved by at least seventy-five percent (75%) of the members of the Company as required by the Operating Agreement of the Company.

**ARTICLE I - NAME**
