

ARTICLES OF ORGANIZATION

OF

TIGER CREEK HUNTING, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The managing member shall hold the offices and have the responsibilities accorded to him by the members as set forth in the Operating Agreement.
