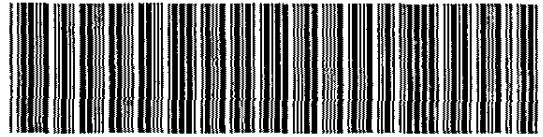

ARTICLE 1: NAME

The name of the limited liability company shall be **CARPENITO ENTERPRISES, LLC.**

ARTICLE 2: PRINCIPAL OFFICE

ARTICLE 3: RESIDENT AGENT

ARTICLE 4: MANAGEMENT

The company shall be managed by the members.

ARTICLE 5: PURPOSE

The company has the authority and shall issue Certificates of Membership to each member evidencing that member's interest in the company. Certificates of Membership shall be signed by a manager of the company.
